

INFORMATION CLAUSE NEWSLETTER

In accordance with Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), OJ L 119, 4.5.2016 - hereinafter referred to as the "GDPR", we would like to inform you that:

1. The Administrator of your personal data is BLACHPROFIL 2 SP. Z O.O. with its registered office in Kraków (30-527), Nadwiślańska 11/139 and its place of business activity in:
 - Grojec, Grojecka 39, 32-566 Alwernia,
 - Dąbrowa Górnicza (41-303), Budowlanych 10.
2. The administrator has appointed a Data Protection Officer - Mrs. Wioletta Kaczmarek, who can be contacted by e-mail: inspektor@bp2.pl.
The Data Protection Officer can be contacted in all matters concerning the processing of personal data as well as the exercise of rights related to such processing.
3. Your personal data will be lawfully processed for the purpose of:
 - sending the NEWSLETTER based on your consent and pursuant to Article 6(1)(a) of GDPR,
 - sending commercial information by electronic means based on your consent and pursuant to Article 6(1)(a) of GDPR and in connection with the implementation of the provisions of the Act of 18 July 2002 on Providing Services by Electronic Means (Journal of Laws of 2002, No. 144, item 1204, as amended).
4. The recipients of your personal data will be exclusively entities authorized by law to obtain such data based and also cooperating with BLACHPROFIL 2 SP. Z O.O.
5. Your personal data will be processed until you withdraw your consent for such processing.
6. You have the right to:
 - access your personal data pursuant to Article 15 of GDPR,
 - correct your personal data pursuant to Article 16 of GDPR,
 - delete your personal data pursuant to Article 17 of GDPR,
 - restrict the processing of your personal data pursuant to Article 18 of GDPR,
 - raise an objection pursuant to Article 21 of GDPR,
 - transfer your personal data pursuant to Article 20 of GDPR.
7. You have the right to withdraw your consent at any time without affecting the lawfulness of the processing that was carried out on the basis of on your consent prior to its withdrawal. .
8. You have the right to lodge a complaint with the President of the Personal Data Protection Office, with its registered office in Warszawa (00-193) at Stawki 2, if you believe that the processing of your data violates the provisions of law on personal data protection.
9. Your personal data will be subject to automated decision making, including profiling. Automated decision making will take place according to the rules specified in the terms and conditions of the Newsletter Service of Blachprofil 2 Sp. z o.o. and the consequence of such processing will be receiving selected marketing information included in the NEWSLETTER, which will not produce any legal effect vis-à-vis you.
10. Providing the data is voluntary; however, failure to provide it shall result in the Administrator's inability to perform his/her tasks, i.e. sending the NEWSLETTER with selected marketing information.
